- I. Call to Order: Meeting was called to order by Chairman Elston at 1:10 p.m. at Heartland Community College in Normal, IL
- II. Roll call and establishment of quorum: Sign-in sheet passed around and quorum established.
- III. Motion was made by Siron and seconded by Thomas to approve June 8 meeting minutes – all in favor - motion carried
- IV. Financial Report:

Thomas asked if the MTU will be returning any funds from FY2010 to the State Training Board. Hetrick reported \$4,299.64 would be returned to the Board. \$4,205.66 of this amount is from the Personnel Services line which is not transferrable to other categories within the budget. The remaining \$93.98 are funds that were not expended in other budget categories.

Motion to approve June, July, and August expenses made by Thomas and seconded by Davis – voice roll call vote taken with all voting yea – motion carried

- VI. New Business
 - A. Director's report on September 1-2 State Training Board meeting
 1. Suburban Law Enforcement Academy (SLEA) is offering web-based Law Update training. The fee is \$15.00/officer for those who sign up by 9/30/10 (will be valid through 12/20/11). The training consists of four (4) 45-minute sessions. For more information or to enroll call SLEA at 800-354-6587.
 2. Crisis Intervention Team Training curriculum will be updated by the State Training Board in October. Updates will include topics such as elderly training.
 3. State Training Board did not have final budgetary meeting with the Governor's office, meaning the State Training Board's budget has not been finalized. The Board has decided it will pay MTU's the lesser amount of either what the MTU was awarded in FY2010 or what was requested for FY2011. The MTU's have received payments for the

first quarter and the remaining amount owed will be paid in a lump sum shortly.

4. Pay increases for Training Board personnel and MTU personnel will be discussed at the December State Training Board meeting.
 5. State Training Board has hired new staff:
 - a. Deputy Director - Larry Smith
 - b. Manager of Mandated Training – Cora Beem
 6. An IDOT representative stated two (2) Standardized Field Sobriety Train-the-Trainer courses will be held with one being held in the Chicago area and the other being held in the St. Louis area. Dates to be determined.
 7. Executive Institute announced new chiefs training will be held in May 2011
 8. \$2.2 million of the camera grant funds have been borrowed by the State
 9. The future of PTI is in question. A report from the Office of the Chancellor at the University of Illinois is expected soon. Western Illinois University has shown interest in the possibility of having a police training academy. Schaefer stated it is estimated it would be 12-18 months prior to a new academy starting if this should happen. There is a lot of exploration being done at this point.
 10. Schaefer mentioned a new law regarding Lead Homicide Investigators that will go into effect in January 2012. The Training Board will put together a committee to determine criteria and what courses will consist of. The committee will send out a survey to all Illinois law enforcement agencies. They are highly encouraged to complete the survey and return it. There is a possibility some investigators may already meet the criteria.
- B. December Board meeting location - December 14 Board Meeting will be held Heartland Community College, Room CCB 1406 at 1:00 p.m. All future meetings will be held at Heartland unless otherwise noted.
- C. All FY2011 dues have been received.
- D. Warner raised concern over training locations and dates being listed on the MTU website. Stated this could pose a security threat for Heartland and officers. The possibility of adding a security measure to the website was suggested. Thomas stated this may be an undue burden on departments and staff. Topic tabled until next meeting.
- E. Scott inquired about the possibility of video recording PPCT practical exercises to have documentation when injuries or alleged injuries occur. Agencies will speak with their council regarding legalities. MTU 8 personnel will contact other MTU's, PTI, ISP, etc. regarding if they video record training, what they record, how long the recording is kept, and any policy they may have in place regarding the topic. Topic tabled until next meeting.
