- I. Call to Order: Meeting was called to order by Treasurer Sandage at 1:05 p.m. at Heartland Community College in Normal, IL
- II. Roll call and establishment of quorum: Sign-in sheet passed around and quorum was established.
- III. Motion was made by Belvery and seconded by R. Bleichner to approve the 6/15/21 meeting minutes – all in favor - motion carried.
- IV. Financial Report: Motion to approve June & July 2021 expenses made by R. Bleichner and seconded by Belvery – voice roll call vote taken with all voting yea – motion carried.
- V. New Business

- VI. Old Business
 - A. Siron stated the FY2022 budget meeting with ILETSB will be held in the Fall. There are funds being received by ILETSB but those funds will not cover all budgets. ILETSB will have general revenue funds available that it didn’t have last year.
- VII. Curriculum
 - A. Siron stated MTU 8 has a need for new PPCT instructors. A PPCT Instructor Certification course has been scheduled for 12/6/21-12/10/21.
 - B. Siron stated the first time someone attends the Sexual Assault Investigator course, they need to attend the in-person Sexual Assault Trauma Informed Response for Patrol prior. For re-certification, the attendee may complete the first day online prior to attending the Sexual Assault Investigator course.
 - C. Hetrick asked if departments would like the MTU to schedule a Breath Analysis Instrument Operator course for the Fall if possible. There was interest in having a course in the Fall as well as the Spring.

D. Siron reminded everyone it has been mandated all officers will need to attend a certified CPR course annually beginning January 2022.

IX. Public Input – Wilson stated the ILEAS Conference will be held in March 2022 at the Crown Plaza in Springfield. STIC pocket guides for cyber security can be requested through ILEAS.
