- I. Call to Order: Meeting was called to order by Chairman Doran at 1:05 p.m. at Heartland Community College in Normal, IL

- IV. Financial Report: Motion to approve June & July 2022 expenses made by Dingler and seconded by Cornwall – voice roll call vote taken with all voting yea – motion carried.
- V. Correspondence
 - A. Hetrick stated correspondence was received from Livingston County Probation and McLean County Probation stating they will be cancelling their MTU 8 membership due to the Administrative Office of Illinois Courts changing their practices regarding probation officer training.
- VI. New Business
 - A. Belvery raised concerns regarding smaller agencies being able to appoint school resource officers with the current requirements in place.
 - B. Hetrick reminded everyone the mandated training pertains to all sworn officers/deputies including Chiefs/Sheriffs.
- VII. Old Business
 - A. Hetrick stated MTU 8's FY2023 budget was approved by ILETSB. The approved budget includes additional funding for the possible purchase of a Use of Force Simulator. The budget was also approved by an email vote of the Executive Board.
- VIII. Curriculum
 - A. Hetrick stated tentative dates have been scheduled to hold ICS 300 & ICS 400 courses on March 20-24, 2023. To solidify those dates, MTU 8 needs to
